### HOW TO REGISTER A FULLY PAID TEAM:

Register online or fill out the form below.

1. Check the box for the day, level, and location you are signing up for.
2. Completely fill in team captain's name, address, day and night phone numbers.
3. Include payment information, (attach check or credit card information below) which includes the entire team fee. **No team is confirmed without being fully paid.**
4. Call, e-mail, hand deliver or mail in your roster and payment.
5. All attached checks and/or credit card numbers on confirmed rosters will be cashed or charged immediately for the full team fee unless otherwise noted and validated by signature.
6. SportsMonkey will call to confirm your team's spot in the league. All leagues are on a first come first serve basis.
7. All rosters are considered final by the second week of play.
8. No refunds will be made on or after the start date. There is a \$25 processing fee for refunds requested 2 weeks prior to the league start date.
9. There will be a \$25 fee for any returned checks.
